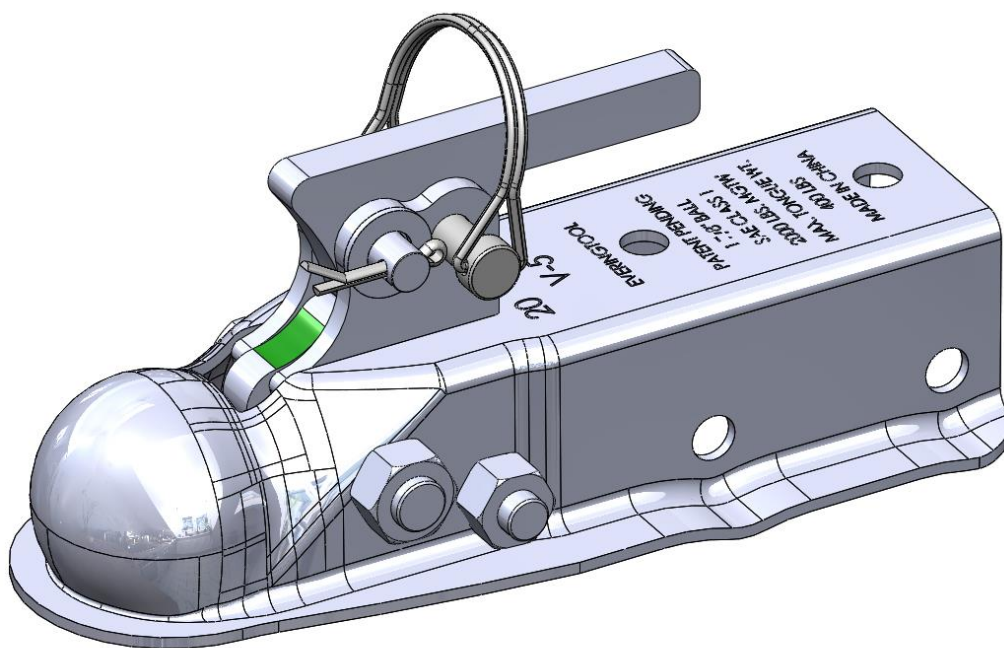

Intended Use

This Ultra-Tow XTP Series Auto Locking Trailer Coupler features an auto-locking system with a steel-lock assembly. The secondary lock has a safety clip designed to fit an off-the-shelf padlock without an adaptor. This coupler can be used with any 1 7/8" ball having a capacity rating equal to or higher than the coupler.

⚠WARNING

- Do not allow persons to operate or assemble the coupler until they have read this manual and have developed a thorough understanding of how it works.
- Do not modify this coupler in any way. Unauthorized modification may impair the function and/or safety and could affect the life of the product. There are specific applications for which the coupler was designed.
- Use the right tool for the job. DO NOT attempt to force small equipment to do the work of larger industrial equipment. There are certain applications for which this equipment was designed. This product will be safer and do a better job at the capacity for which it was intended. DO NOT use this equipment for a purpose for which it was not intended.
- Industrial or commercial applications must follow OSHA requirements.

⚠WARNING

WORK AREA SAFETY

- Inspect the work area before each use. Keep work area clean, dry, free of clutter, and well-lit. Cluttered, wet, or dark work areas can result in injury. Using the coupler in confined work areas may put you dangerously close to other cutting tools and rotating parts.

- Do not use the coupler where there is a risk of causing a fire or an explosion; e.g., in the presence of flammable liquids, gases, or dust. The product can create sparks, which may ignite the flammable liquids, gases, or dust.
- Do not allow the coupler to come into contact with an electrical source. The tool is not insulated and contact will cause electrical shock.
- Keep children and bystanders away from the work area while operating the coupler. Do not allow children to handle the coupler.

PERSONAL SAFETY

- Stay alert, watch what you are doing, and use common sense when operating the coupler. Do not use the coupler while you are tired or under the influence of drugs, alcohol, or medication. A moment of inattention while operating the tool may result in serious personal injury.

- Check for damaged parts before each use. Carefully check that the product will operate properly and perform its intended function. Replace damaged or worn parts immediately. Never operate the product with a damaged part.
- Store the coupler when it is not in use. Store it in a dry, secure place out of the reach of children. Inspect the tool for good working condition prior to storage and before re-use.
- Use only accessories that are recommended by the manufacturer for use with your product. Accessories that may be suitable for one product may create a risk of injury when used with another tool. Never use an accessory that has a lower operating speed or operating pressure than the tool itself.

Specific Operation Warnings

⚠WARNING

- Maintain an adequate vertical down (tongue) load to maintain control of the trailer (generally 10%), but without exceeding the specified rated capacities.
- Other steps and inspections are also required Consult OSHA, D.O.T. regulations, and the American Trucking Association for complete coupling and uncoupling procedures.
- Check that ball load rating is same as or greater than coupler load rating.
- ALWAYS use safety chains.
- DO NOT use top holes for mounting.

Towing

⚠WARNING

- Use only with trailers and equipment designed for on-road towing within the stated capacities.

Installation Instructions

⚠WARNING

- Use a secure mounting structure of sufficient strength to support the rated capacity of the coupler in accordance with SAE J684.
- Bolt the coupler to the front of the trailer tongue, bolting through the coupler's side holes. Use 3/8" diameter grade fasteners (8), properly tightened (not included).
- Additional bolts may be used in the top holes for extra strength, if desired.
- The recommended minimum torque is 37 ft-lb. (per SAE J429).

Before Each Use

⚠WARNING

- Inspect the unit for proper operation.
- Inspect, in particular, the coupling area. Replace when the wear exceeds 1/8" (.125") from the original surface profile.
- Inspect the coupler for worn, damaged, and missing parts. Replace as required.

Operating Instructions

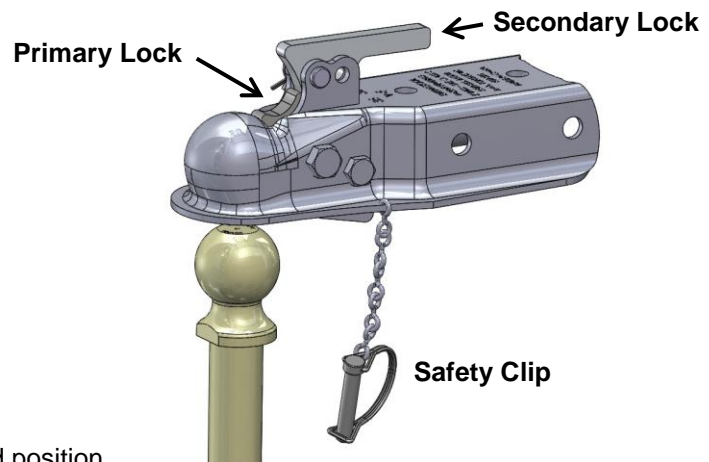
⚠WARNING

- It is the user's responsibility to be sure the hitch tongue is capable of a 400 lb. vertical load and a 2,000 lb. gross trailer weight.
- Every time the coupler is used, make sure the ball is completely engaged in the socket and the

coupler is securely locked. Failure to do so could result in a serious or fatal injury.

- Safety chains must be used in a criss-cross manner under the coupler allowing only enough slack for turns.
- Make sure all parked units are on a hard, level surface and engage all safety devices.
- Double check that lights are installed and are working properly.

Auto Lock Function



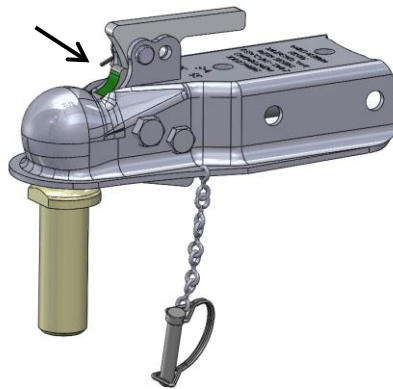
Unlocked Position

The illustration shown is in the unlocked position. When the Primary Lock does not show a green color, the coupler is open.

Hitching Up

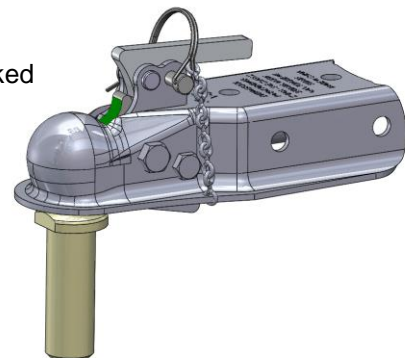
1. Before operating, inspect for proper operation, worn, damaged, or missing parts.
2. Unlock the coupler by removing the Safety Clip. Insure that the Primary Lock does not show green. The green color indicates the coupler is locked.
3. Back the vehicle up to the trailer until 1 7/8" of the ball is under the trailer hitch (shown above).
4. As you lower the trailer hitch onto the ball, the Primary Lock and Secondary Lock will shift to the locked position, as shown.

Green = LOCKED



Locked Position

The illustration shown to the right is in the locked position with the Safety Clip installed. Insure that the lock assembly is in the unlocked position before hook-up.

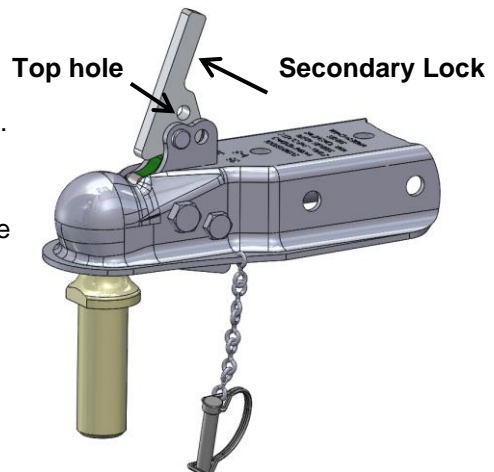


Un-Hitching

1. Unlock the coupler by removing the Safety Clip.
2. Flip the Secondary Lock forward until it is pointing up.

Hold it while raising the jack.

3. If both hands are needed, the Secondary Lock can be held by inserting the Safety Clip into the **top hole** while raising the jack.



4. Jack up the trailer hitch until it clears the hitch ball and pull out the Safety Clip. The unit is now back to the unlocked position, as shown in the first illustration.

Maintain the coupler by adopting a program of conscientious repair and maintenance in accordance with the following recommended procedures. It is recommended that the general condition of any tool be examined before it is used. Keep your tool in good repair. Keep handles dry, clean, and free from oil and grease. The following chart is based on a normal operation schedule.


Maintenance Interval	Maintenance Point
After the first 200 miles of towing.	Check the torque specification of the hitch ball and re-torque if necessary.
After every 400 miles of towing.	Check the torque specification of the hitch ball and re-torque if necessary.
The following should be performed every 10,000 miles or 6 months.	<ul style="list-style-type: none"> • Inspect for proper operation. • Inspect, in particular, the coupling area. Replace when the wear exceeds 1/8" (.125") from the original surface profile. • Inspect for worn, damaged, and missing parts. Replace as required. • Always use the Safety Clip.


Troubleshooting

Use the table below to troubleshoot problems before contacting service personnel or your local dealer. If the problem continues after troubleshooting, call your local dealer for assistance.

Failure	Possible Cause	Corrective Action
Coupler will not drop down over the hitch ball.	Debris is packed into the coupler.	Remove all debris from the coupler.
	The Primary Lock is not in the correct position.	Before connecting, make sure the Primary Lock does not show green; green means it's locked.
Coupler will not release the hitch ball.	The Secondary Lock is in the locked position.	Flip up the Secondary Lock and jack up the trailer.

If the product does not comply with this limited warranty, Your sole and exclusive remedy is that We will, at our sole option and within a commercially reasonable time, either replace the product or product component without charge to You or refund the purchase price (less shipping). This limited warranty is not transferable.

Limitations on the Warranty
