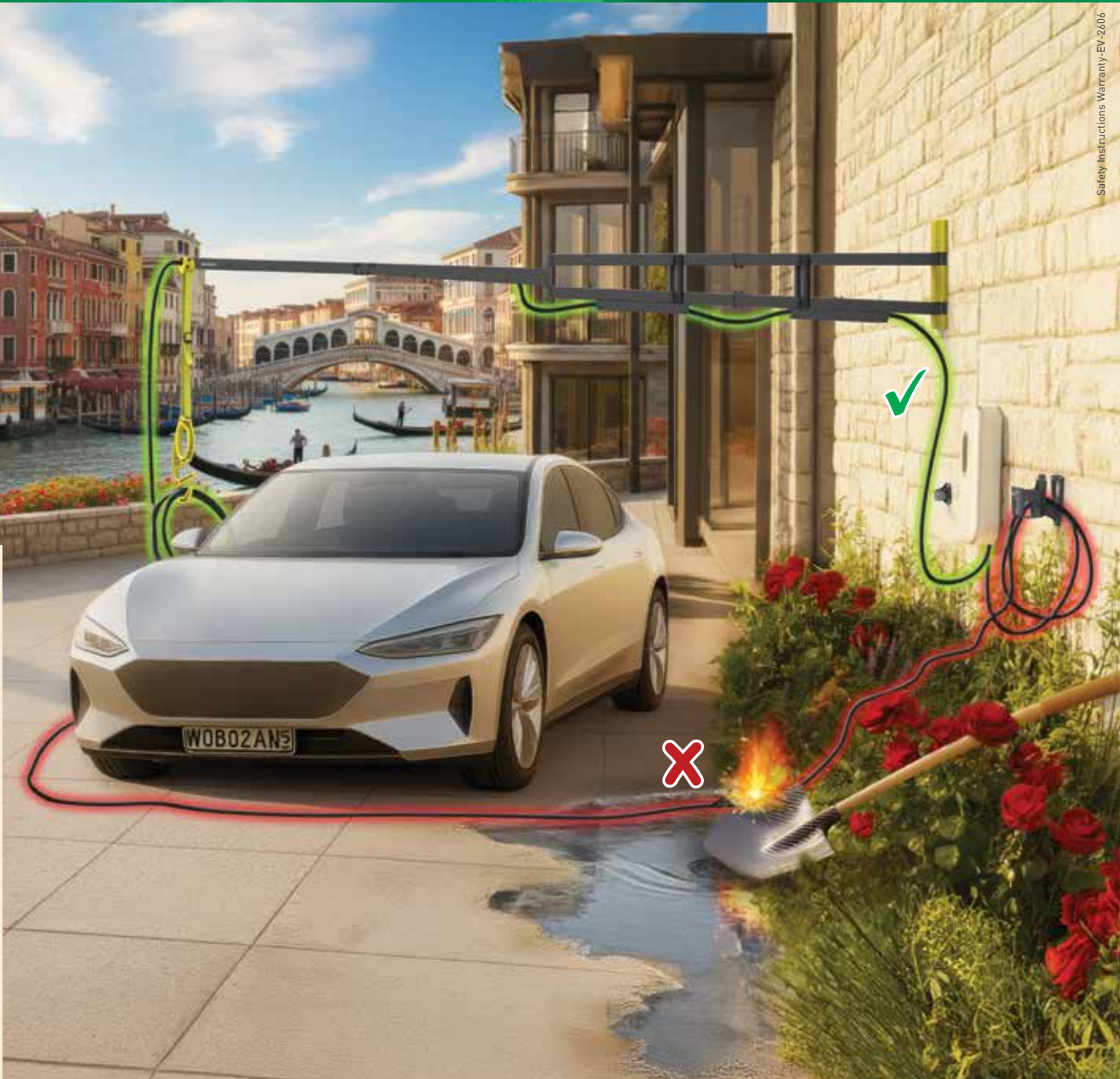

Electrical shock hazard! Installation of EV charger pedestals is permitted only on stationary floors, walls, or ceilings made of concrete, and must be performed by a licensed electrician in accordance with local electrical codes, including proper grounding and bonding. The supplied fixtures are suitable for concrete installation only.

Consult a professional structural engineer and a contractor to determine the required installation accessories and concrete foundation for the pedestal.

The installer is solely responsible for the concrete foundation, the installation and its safety.

Barkan is not responsible for damages resulting from improper installation or improper use of the product.

DANGER! Failure to follow the safety and assembly instructions may result in serious personal injury, death, property damage, and/or the fall of your EV charging equipment.

If you are unable/ lack the experience to carry out wall, ceiling, or floor installation, contact us for further advice. If installed by an equipped professional, please make sure they have the necessary assembly experience, have read and understood the safety and assembly instructions, work according to these instructions, and take responsibility for the installation.

1. Arm and pedestal installation surface – It is permitted to install this product only on stationary floors, ceilings, and walls made of: concrete, standard concrete blocks greater than 4" / 10cm, directly to the concrete or blocks, or on standard 2"x4" wood studs.

It is not permitted to be installed on wall cladding or plaster.

It is not permitted to install the supplied hardware on gypsum, aerated concrete, silicate, walls with water damage, weak/old blocks, or wood boards.

It is permitted to be installed on a solid wood pergola post, with a minimum size of 4" x 4" / 10 x 10 cm. The attachment to the post should be checked every six months to ensure it is secure and has not come loose.

After charging is complete, and in case of extreme weather conditions, fold the arm in and push it flush against the wall.

2. Placement and height of installation - The wall arm needs to be installed in a way that doesn't allow people to collide with the product and become injured. The recommended height from the ground is 90" / 230cm.

3. Keep children and bystanders away from the assembly area.

4. Tightening of fasteners – Screws or bolts with a diameter of 1/4" / 6 mm or less must be tightened very carefully to avoid breakage.

5. Installation strength test - Once installation of the product is complete, load weight onto it according to the requirements set forth in the assembly instructions.

6. Check EV charging equipment connection - After installation, verify that the EV charging equipment is securely connected to the product and cannot fall or become disconnected.

7. Periodic maintenance checks - One month after installation, please check the following:

A. The product is still tight against the surface on which it was installed.

B. That the EV charging Equipment is attached securely to the product.

C. Any and all nuts, bolts, and straps have not become loose.

Repeat the maintenance checks every six months following installation.

If any faults are found, remove the EV charging equipment from the product and reassemble the product as per the assembly instructions.

8. Wall arms - Oil the hinges during installation and once a year after that. Also, oil the hinges whenever they become hard to move or if you identify rust on them.

Move the mount gently using the handle only. Do not pull the cable or apply downward force on the mount, as this could disconnect it from the wall.

Opening the package indicates your acceptance of and agreement to read and follow the safety and assembly instructions.

If you do not agree to these terms, return the product in its original packaging for a full refund.

This product is intended for use only up to the maximum weight as indicated on the box. Using heavier products might cause injury.

LIMITED PRODUCT WARRANTY

Dear Customer – Thank you for purchasing Barkan's high quality product. We hope you enjoy it.

The warranty period for each product is indicated on the product packaging and on the company website www.barkanmounts.com. The warranty period begins on the date of purchase, as shown on the original proof of purchase.

This warranty does not affect the consumer's statutory rights under applicable law.

The product is intended for self-installation; however, the installer is solely responsible for the installation and its safety.

Barkan may repair or replace the product at its discretion in our warehouse, free of charge, on the condition that it is determined that it is flawed due to improper manufacturing or improper raw materials. When filing a claim under this guarantee, return the product using prepaid freight, with the original purchasing document, to the dealer or Barkan distributor.

The warranty does not cover the following:

Detachment, collapse, or fall of the product or of the EV charging equipment attached to it; damage related to their installation; personal injury or property damage; or any direct, indirect, incidental, consequential, punitive, or other damage caused by:

1. Failure to follow the product's safety, assembly, and use instructions, including improper installation or improper use of the product.
2. Attachment of any load-bearing device, arm, adapter, accessory, or support component not manufactured by Barkan and not intended or approved by Barkan for attachment to the product.
3. Changes or modifications made to the product, not by Barkan.
4. Accidents or force majeure incidents.
5. Vandalism or intentional damage to the product.
6. Damage caused to the EV charging equipment or the surroundings due to the use of this product.
7. Paint defects and scratches.
8. Defects caused by ordinary wear and tear and deterioration, due to regular and frequent product use.
9. Breaking of plastic covers and parts, tearing of a strap.
10. For indoor-use products: Any use outdoors is prohibited and will void this warranty. This includes, but is not limited to, damage such as rust, peeling, or swelling caused by water, cleaning agents, or humidity.
11. Extreme temperatures, severe weather, or other extreme environmental conditions.

In the event of any discrepancy between language versions, **the English version shall prevail**. Barkan shall not be liable for any incidental, indirect, or consequential damages, or any punitive damages, to the maximum extent permitted by law, from the use of this product.
